

Payment Agreement Contract

By this contract, agrees to make payments to **Lou Sutton Photography** hereafter known as "Service Provider," by the following schedule in exchange for a **monthly photography plan**.

By this agreement, it is agreed that a payment of Will be transferred by direct debit to the Service Provider **every month** until the total of the payment required, which is has been delivered.

These payments include any interest and other charges that may apply.

This agreement is binding, and failure to meet its terms will allow the Lender to take certain recourse. Insufficient payments and bounced transactions will need to be paid within 5 working days. If payment should not be delivered at all, service provider will be entitled to end all services immediately.

In addition, the following terms and conditions apply:

Terms & Conditions

*Payment will be taken by direct debit monthly - on the 1st of each month for 12 months only.

*Payment may be taken before or after this date when the 1st lands on a weekend.

*Your plan will start on the 1st of the following month of your initial payment and end on the last day of your last months' payment.

(example: last payment – 1/07/20, your plan will end on 31/07/21)

*This is a 12 month plan. If your direct debit fails or you cancel this plan prematurely, you will be invoiced for the full remaining balance if the services you have used exceed the combined payments you have made. To work out the balance due, each service you have used will be invoiced at it's full price, without discounts and the payments you have made will be deducted from the total. This payment will then be due within 10 working days of your last payment due date. Failure to complete this transaction will result in legal action.

*In the event that you cancel your plan without using all of your services, Lou Sutton Photography will not return any funds nor will they provide any future services as 'owed'.

*Your plan will stop if you choose to cancel your plan, effective immediately.

*All services chosen by the client will be as stated on www.lousutton.co.uk and will include the image quantity and session time listed. All additional changes to your service will be charged as normal.

*All mini sessions are subject to change each year.

*Upgrade on mini sessions is not included in your monthly plan. This must be covered as an additional payment upon booking by the client.

*Sessions include digital images, prints are not included. The quantity varies for each session.

Please see www.lousutton.co.uk/prices for details on each package.

*Bookings must be made in advance and are subject to availability.

*A deposit may be required to reserve your sessions. This will be returned on the day of your session once you have attended. Your deposit will not be returned in the event of no-shows or cancellations.

*Plans that include hourly photography may be used against any studio and indoor session but not including;

-Weddings

-Events

*If you have remaining, unused photography time within your plan period, you may add it to an additional session, paid in full. Remaining time may not be carried across to a new plan after your plan end date.

*Your plan details are final. Changes to your plan can not be made and exchanges of services are not permitted.

*Extra image packages (where included) can be used throughout the year on multiple sessions.

*Additional images will require payment as usual once you have exceeded your package limit.

By signing this agreement, all parties agree to the terms as described above. Alterations to this agreement can only be made by both parties and must be placed in writing. Both parties will receive a printed copy of this agreement, and will be responsible for upholding its terms.
